4) Update on Western Australia State sponsorships

WA State Nominated Migration Program opening soon Invitations to apply for the State Nominated Migration Program will resume in January 2021.

The Western Australian State nomination criteria have been revised inline with State health and economic recovery priorities. The changes to the criteria are as follows. Intending applicants must be currently residing in Australia to be invited and nominated. Intending applications subject to a section 48 bar, are not eligible for State nomination.

If you are applying through the Graduate stream and due to COVID-19 you completed some of your Western Australian studies online (either onshore or offshore), you are now able to use this study toward the Western Australian study requirement.

9) English scores required by DHA

English scores required following PTE review of their score levels - This information received from DHA ...

English testing organisations will sometimes adjust their score ranges as new research and knowledge about English testing is developed. We consider these changes carefully before we make any adjustments to the scores required for our English Levels. Where it is decided that scores will change, a notice will be put on our website with information on how it may impact you.

10) Travel requirements to Australia

From 22 January 2021, if you are travelling to or transiting through Australia you must provide evidence of a negative COVID-19 (PCR) test to your airline, taken 72 hours or less before your scheduled departure.

If you do not have evidence of a negative COVID-19 (PCR) test, you should not go to the airport as your airline will not allow you to board the aircraft.

Masks must be worn on all international flights, including at airports.
