## 2) Interim Report on changes to Australia's Migration Program

The Joint Standing Committee on Migration today presented an interim report for its inquiry into Australia's skilled migration program.

Committee Chair Julian Leeser MP said that "The Committee has heard repeatedly that skilled migrants create Australian jobs. With over 500,000 temporary visa holders leaving Australia during the COVID pandemic, we need to bring back skilled migration, to fill essential gaps and to help create more jobs for Australians."

"Skilled migrants provide much needed skills to fill skills gaps, offering businesses the opportunity to better meet demand and expand, and to pass on their skills to Australians," Mr Leeser continued.

"Australia has always been an attractive destination for migrants. Our excellent response to the health and economic challenges of the COVID-19 pandemic has made Australia an even more attractive destination. Now is the time to attract highly talented individuals and businesses to Australia."

"The report recommends a number of measures to streamline the system to ensure we can capitalise on the opportunity in front of us," said Leeser.

The interim report makes recommendations focused on assisting in recovery from the economic effects of the COVID-19 pandemic. The inquiry will continue with a wider focus on long term reform of the skilled migration program. Submissions responding to the terms of reference will be accepted until 31 March 2021.

### List of Recommendations

#### Recommendation 1

2.76 The Department of Home Affairs should streamline labour market testing to:

§ be less prescriptive about what constitutes labour market testing

§ only require Medium and Large businesses to conduct labour market testing;

§ require labour market testing for businesses headquartered outside Australia or businesses owned by someone who is not an Australian citizen;

§ remove the requirement for employers to advertise any occupations which are on the PMSOL or critical skills lists; and

§ remove the requirement for employers to advertise for all occupations classified as Skill Level 1 and 2 on the jobactive website.

#### Recommendation 2

2.80 The Committee recommends that at least until the pandemic period is over, the Department of Education, Skills and Employment and the Department of Home Affairs remove the requirement for employers to pay the Skilling Australia Fund as part of the visa sponsorship process.

If the levy is retained:

– Consideration should be given to aligning the payment of the levy to the commencement of employment of the skilled migrant or guarantee a refund to the sponsor if the application is unsuccessful.

– If the employer can demonstrate they have spent the same amount or more than the levy in the previous 12 months on training their Australian employees in skills relevant to their work for the employer, they should not be required to pay the Skilling Australia Fund levy.

– The Federal Government should establish greater transparency over the State Governments' use of funds from the Skilling Australia Fund to skill Australians.

### Recommendation 3

3.113 The Committee recommends that the Department of Home Affairs be required to provide greater transparency on where employer sponsored visa applications are in the queue.

### Recommendation 4

3.116 The Committee recommends that the visa conditions for sponsored skilled visa holders working in industries that require migrants to work for different employers or to undertake multiple roles with the same employer to meet practices of the industry, be adjusted to allow them to work for multiple employers without making applications for new visas.

### Recommendation 5

3.127 The Committee recommends that the Priority Migration Skilled Occupation List be expanded urgently to include Chefs, Veterinarians, Café and Restaurant Managers and Seafarers.

### Recommendation 6

3.128 The Committee recommends that the Department of Home Affairs conduct an urgent review of the Priority Migration Skilled Occupation List, in consultation with relevant stakeholders, with a view to expanding the number of occupations to better reflect the urgent skills shortages in the context of the COVID-19 pandemic recovery. The Department should give particular consideration to civil engineers, electrical engineers, motor mechanics, cooks, carpenters, electricians and other roles in the hospitality, health, trades, agriculture and manufacturing sectors.

### Recommendation 7

3.129 The Committee recommends that the Short-term Skilled Occupation List, the Medium and Long-term Strategic Skills List and the Regional Occupation List be reviewed as soon as practicable to ensure that the lists most accurately reflect Australia's employment challenges as the economy emerges from the COVID-19 pandemic.

### Recommendation 8

3.132 The Committee recommends the Government reserve places on flights and in quarantine for skilled migrants.

### Recommendation 9

3.135 The Committee recommends that:

§ The Department of Home Affairs improve visa processing times for employer-sponsored visas because of the labour market needs during the COVID-19 pandemic economic recovery; and

§ The Department of Home Affairs expedite the processing times for skilled visa holders who have remained onshore in relevant employment seeking a subsequent skilled visa or permanent residency visa.

### Recommendation 10

3.144 The Committee recommends that all employer sponsored visa holders be given a clearer pathway to permanency.

Recommendation 11

4.75 The Committee recommends the establishment of a global marketing campaign to attract global talent and investment. This campaign should:

§ Target talented individuals and investors in key competitor countries;

§ Raise awareness of both the opportunities in Australia, and the migration mechanisms available to those seeking to live, work or settle in Australia; and

§ Leverage off the work already being undertaken by the Special Envoy for Global Business and Talent Attraction.

Recommendation 12

4.76 The Committee recommends that the BIIP and GTI provide options for both automatic permanent residence and temporary visas with a clearly articulated path to permanent residence.

### 3) Western Australia State (unofficial) invites March 2021

Western Australia had their March round last week  
We have seen a lot less invitations this month

That could be because of the state conventions of not being able to do much processing in the official state election period (which officially ends today). Also there may be limited people eligible due to only being able to invite onshore and those not effected by s48 bars).

We have seen no invites for chef and expect this occupation may be nearly exhausted for the 2020/21 program year. WA had to fight hard to get this on their WA list so not surprising given the heavy demand that this may be closed or near closed.

Lowest ranked invite for University graduates that WE saw was

- Bachelor degree 85 points (no EOI date available)

For Vocational education students was

- Advanced Diploma 65 points (EOI lodgement 25/2/2021)

There may well be lower ranked invites at Diploma level but we have not seen those with our clients.

## 4) Statistics on Victoria's State Migration Program

### Places filled

#### **Skilled nominated visa (subclass 190) - State nomination program**

2,500 places have been allocated to Victoria. As at 28 February 2021, for the 2020-21 program 5,121 ROIs have been received and 1,043 applications have been made for Victorian visa nomination.

#### **Skilled Work Regional (Provisional) visa (subclass 491) - State nomination program**

1,043 places have been allocated to Victoria. As at 28 February 2021, for the 2020-21 program 701 ROIs have been received and 209 applications have been made for Victorian visa nomination. The Skilled Work Regional (Provisional) visa provides opportunities for skilled professionals to gain further work experience in Regional Victoria. Subclass 491 visa holders may be eligible to then apply for the Permanent Residence (Skilled Regional) visa (subclass 191)[external link](#).

### Places as at 28 February 2021

#### Registrations of Interest selected

##### **Subclass 190**

As at 28 February 2021, 1,140 of 5,121 ROIs have been selected to apply for Victorian visa nomination.

##### **Subclass 491**

As at 28 February 2021, 270 of 701 ROIs have been selected to apply for Victorian visa nomination.

## 5) Iscah summary of January 2021 Skill Select round (189/491)

DHA have finally released their results from the January skill select round.

Just 200 189 invites and 163 in the 491 Family category

Invites were at 65 points for 189 (EOI effect date of 04/2020)

Family 491 also at 65 points (EOI effect date of 11/2020)

The ONLY Pro rata occupation that got invites were in the 2339 group

95 points for 189 (EOI effect date of 10/2020)

70 points for 491 family (EOI effect date of 09/2020)

I expect that the 2021/22 program numbers will reflect that when we see the May 2021 budget announcements. Currently the program sits at just 6,500 grants . I expect it to more than double this in the next program year.

## 6) Message from DHA about claiming work points

Skilled Employment Experience - Closely Related Occupations You can only claim points for employment if it is in your nominated skilled occupation or a closely related skilled occupation. A closely related skilled occupation is an occupation listed under the same four (4) digit ANZSCO Unit Group. If you claim points for employment that is not in your nominated skilled occupation or a closely related skilled occupation, and you subsequently lodge a visa application, it may be refused. ## 7) Tasmanian State Migration news

Tasmania High Calibre able to move from 491 to 190

From Tasmanian State government -

High calibre subclass 491 category applicants may be considered for subclass 190 nomination

We will consider applicants who have applied for nomination in any of the subclass 491 categories for subclass 190 nomination if they can demonstrate that they are a "high calibre" candidate, even if they do not meet the subclass 190 category requirements. Applicants who believe they warrant consideration as high calibre candidates should supply a written submission included in the Commitment Letter of their application outlining their reason(s) for their request.

Positive attributes include:

- Employment in highly skilled, specialist positions (normally ANZSCO 1 or 2)
- Rare/unique skills in high demand
- Specialist health/allied health skills and employment (in a health related setting)
- Recent graduate of a TSOL related occupation, with prior skills/experience and can demonstrate strong employment opportunities
- Employment directly related to nominated occupation, with highly reputable, well known company
- Employed in skilled area of high demand, having lived in Tas for 2 years or more
- Extensive residence in Tas (over 3 years) with solid and ongoing skilled employment

Possessing any or all of these does not guarantee we will agree to subclass 190 nomination.

Important note: please DO NOT email to enquire eligibility as a 'high calibre' calibre applicant – we will not make an assessment before receiving your application. Select both 491 and 190 on your Skillselect EOI and include your request to also be considered for subclass 190 in your Commitment Statement.

## Change in Tasmanian criteria for those who start study after graduate after 30 June 2021 –

If you commenced your last course of study in Tasmania after 30 June 2021

- You must have completed a course of study and obtained a letter of completion from a tertiary institution in Tasmania registered on the Commonwealth Register of Institutions and Courses for Overseas Students (CRICOS)
- Your course of study must be listed on CRICOS with a duration of at least 92 weeks\* and must have been completed full time and on-site in Tasmania
- You must have lived in the state for at least 2 calendar years from the commencement of your course and for the duration of your studies
- You and your dependents must currently be living in Tasmania and demonstrate a genuine commitment to continue to live in Tasmania
- If you are not currently in skilled employment you must provide a career plan that explains how your studies have increased your ability to find skilled work in Tasmania. This may include areas unrelated to your Tasmanian study
- Your study does not need to be related to your nominated occupation, however a relevant skills assessment will be highly regarded.
- If you held a Student visa (subclass 500) when you completed your last course of study in

Tasmania, the study must be:

> a degree (bachelor, masters or any higher degree), or a diploma (standard, advanced, associate or graduate); or

> a qualification directly related to a Priority Industry Training and Workforce Development

> Area (current at the time you commenced study) at the minimum qualification level specified for that area.

- If you held a visa that was NOT a Student visa (subclass 500) at the time you completed your last course of study in Tasmania, the study MUST be directly related to a Priority Industry Training and Workforce Development Area (current at the time you commenced study) at the minimum qualification level specified for that area.

Please note: only one course of study leading to one qualification may be included, unless it is part of an articulated pathway or packaged course, eg. a 2 year Certificate III – IV Commercial Cookery Pathway.

VET : Diploma - 95 points EOI submission date: 17/02/2021

## 14) NSW update on State Migration

S48 bar

The section 48 bar applies to applicants who are holding a bridging visa, and have had a visa refused or cancelled, since their last entry into Australia. If you are subject to a section 48 bar you need to leave Australia before you can reapply for a visa.

NSW will not renominate applicants who are subject to a section 48 bar where their nomination has expired, and they are unable to leave Australia.

Nomination allocations provided by the Department of Home Affairs are limited and it is currently uncertain when border restrictions will be lifted.

To ensure the limited nomination positions allocated to NSW go to support the economic recovery of the state, NSW will not renominate applicants subject to a section 48 bar.

Skilled Nominated visa (subclass 190)

The process for applying for NSW nomination for the Skilled Nominated visa (subclass 190) remains the same, with invitations sent periodically to selected candidates.

Skilled Work Regional visa (subclass 491)

Regional Development Australia (RDA) offices have commenced, or will soon commence, accepting and assessing applications for nomination. A list with the participating RDAs can be found on our subclass 491 visa website.

Nomination criteria is consistent across all regions and can be found on our subclass 491 visa website.

Expressions of Interest with earlier dates of effect are invited before later dates.

## 18) January Skill Select 190 and 491 (family) results

Due to high levels of demand, and in keeping with previous program years, the below occupation groups will be subject to pro rata arrangements to ensure availability of invitations across the program year.

SkillSelect first allocates available places to Skilled – Independent visas (subclass 189), and thereafter the remaining to Skilled Work Regional (Provisional) visa (subclass 491) – Family Sponsored . If all places are taken up by subclass 189 visas then there will be no invitations issued for subclass 491 visas in these occupations.
